The U.S.A 9 digit social security number.

### **3. CANADA**

<u>For the certification of the insurance time:</u> the Canadian 9 digit social security number and -if available-documents of employment /insurance (certified copies). If the Canadian insurance number is unknown or non existent, it should be found. The insured should contact the competent Office in Canada (International Operations, Service Canada,

P.O. Box 2710, Station Main, Edmonton (Alberta), AB T5J2G4, tel.nr: .001-800-277-9914) in order to be provided with before applying.

Otherwise, delays are highly likely.

<u>For the certification of residence time:</u> the Canadian 9 digit social security number, certified copies with dates of entrance and exit from Canada as well as any document asserting the legal residence of the insured in Canada.

#### 4. QUEBEC

The Canadian 9 digit social security number of Quebec and-if available- documents of employment /insurance (certified copies). If the Canadian insurance number of Quebec is unknown or non existent, it should be found. The insured should contact the competent Office in Canada (International Operations, Service Canada, P.O. Box 2710, Station Main, Edmonton (Alberta), AB T5J2G4, tel.nr: .001-800-277-9914) in order to be provided with before applying. Otherwise, delays are highly likely.

# **5. COUNTRIES OF LATIN AMERICA (BRAZIL, ARGENTINA, URUGUAY, VENEZUELA)**

Certified copies of : contributions booklet, employment booklet, passport or/and identity card (of the Greek State and of the country of employment) as well as documents corroborating the employment in the foreign country.

#### 7. NEW ZEALAND

Certified documents attesting the legal residence in New Zealand. (e.g passports)
